**Addendum Notification**

It is hereby notified that the following List of physically handicapped candidates is added as List II to the Ranked List No.220/08 came into force with effect from 18.09.2008 for the post of Last Grade Servants in various department in Alappuzha district. This list contains the names of the physically handicapped candidates found suitable on the basis of the result of the Objective Type Test (OMR valuation) held on 30.06.2007, verification of documents and the two stages of suitability assessment conducted on 16.07.2008 and 07.08.2009 at the District Office, KPSC District Office, Alappuzha.

According to the existing procedure, re-valuation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of List II of the Ranked List if prescribed fee of Rs.50/- (Rupees fifty only) is remitted as any of the Treasuries in the state by chalan under the head of account "0051 PSC-105 State PSC-99-Examination fee". Application for re-checking of the answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or down-loaded and printed in A4 size paper from the Commissions website [www.keralapsc.org](http://www.keralapsc.org). or photocopied there from. The original chalan receipt for the prescribed fee should be produced with the application for re-checking. [Those candidates who were already included in the List I of the Ranked List and have availed the chance for re-checking of answer scripts are not eligible for making use of this opportunity].

Valid applications for re-checking addressed to the District Officer, KPSC District Office, Alappuzha 688001 should reach this office within 30 days from the date on which this notification of Ranked List is officially released by the Commission. Application for re-checking received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded.

In the case of candidates who send applications for re-checking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be re-checked and the result of re-checking will be intimated to the candidates from this office.

This addendum Ranked List to the Ranked List No.220/08 dated 18.09.2008 for the post of Last Grade Servants (Various) in Alappuzha District, has the validity with effect from 18.09.2008 and will be in force till the expiry of the List I of the Ranked List.
