FINAL EXAMINATION

No candidates have qualified in the final examination held on 27.12.2006, 28.12.2006 and 29.12.2006.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked if the prescribed fee of Rs.50/- (Rupees Fifty Only) per paper is remitted in any one of the treasuries in the State by chalan under the head of account “**0051 PSC – 105 State PSC – 99 Examination Fee**”. Application for rechecking should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or downloaded and printed in A4 size paper from the Commission’s website www.keralapsc.org or photocopied there from within one month from the date of publication of the result. The original chalan receipt for the prescribed fee should be produced along with the application for rechecking.

Valid applications for rechecking addressed to the **Deputy Secretary (Examinations) II, Office of the Kerala Public Service Commission, Pattom Palace P.O., Thiruvananthapuram – 695 004** should reach this office within 30 days from the date on which Eligibility List is officially released by the Kerala Public Service Commission. Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send application for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded by the examiner will be rechecked a second time and if it is found that it has been omitted to value a question or a sub division of a question, the paper will be got revalued by the same examiner and the result of the rechecking will be intimated to the candidates.

Copy of the mark lists will be issued on requisition by remitting a fee of Rs.20/- (Rupees Twenty only) per paper by way of chalan in any one of the Treasuries under the head of account “**0051 PSC – 105 State PSC – 99 Examination Fee**”. Application for mark list should be addressed to the Deputy Secretary (Examinations) II, KPSC, Pattom , Thiruvananthapuram – 4.
