The following list contains the names of the candidates found suitable on the basis of the result of the Objective Type Test (OMR Valuation) held on 15.02.2008 and verification of the original documents of the candidates included in the probability list published on 4.10.2008 for the post of **L D TYPIST (Ex-Servicemen only)** on **Rs. 4990-7990** in NCC/Sainik Welfare Department in Alappuzha District arranged in the order of merit. The Ranked List is published on the basis of the Gazette notification for the post dated 14.02.2007 as Category No. 24/2007. for recruitment. The Ranked List is brought into force with effect from 1.12.2008. The Ranked List will be in force till the publication of a new Ranked List for the post after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of answer script is not allowed. But answer scripts will be re-checked only after the publication of Ranked List, if prescribed fee of Rs.50/- (Rupees fifty only) is remitted in any one of the Treasuries in the State by chalan under the head of account ``0051 PSC- 105 State P S C - 99 – Examination fee.`` Application for re-checking of the answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or down-loaded and printed in A4 size paper from the Commissions Website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered.

The applications for re-checking along with the original chalan receipt for the prescribed fee addressed to the District Officer, K P S C District Office, Alappuzha 688 001 should reach this office within one month from the date of publication of the Ranked List officially released by the Commission. Application for re-checking received after the prescribed time limit or not in the prescribed form will not be entertained.

Entries put in column(4) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, KPSC District Office, Alappuzha within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

The candidates who have obtained 9(Nine) marks and above were included in the Main List of the Ranked List.
