The application for rechecking along with original chalan receipt for the prescribed fee for Rs.50/- under the head of account “0051 - PSC 105 State PSC 99 – Examination Fee” addressed to **the Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom Thiruvananthapuram – 4** should reach the office within 30 days from the date of publication of the Ranked List. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.
