NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Dictation Test held on 06.10.2007, the verification of original documents of candidates held on 06.10.2008 for selection to the post of **CONFIDENTIAL ASSISTANT GRADE II (SR for SC/ST) on Rs. 3590-5400** in the Various Department in Pathanamthitta District arranged in the order of merit. The Ranked List is brought into force with effect from 03.12.2008. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer scripts is not allowed. But rechecking of marks will be done on payment of Rs.50/- (Rupees fifty only). The fees should be remitted in any one of the treasuries in the state by chalan under the Head of Account "**0051-PSC-105-State PSC-99 Examination Fee**". The fee once remitted will not be refunded on any account. The result of the re-checking will be intimated to the candidates from this office. Application for re-checking of answer script should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website:- www.keralapsc.org of photocopied there from. Applications submitted in any other manner will not be considered. The application for re-checking along with the original chalan receipt for the prescribed fee addressed to the **District Officer, KPSC District Office, Pathanamthitta** should reach this office **within one month** from the date of publication of the Ranked List officially released by the Public Service Commission. The application for rechecking received after the prescribed time limit will not be entertained.

Entries put in column 4 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Pathanamthitta **within one month** from the date of publication of the Ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

All eligible candidates who have attended dictation test held on 06.10.2007 have been included in the Ranked List. The cut off marks have been lowered to the extent necessary in respect of candidates included in the Supplementary Lists.
