### NOTIFICATION

Application for rechecking after the stipulated time will not be entertained and fee once remitted will not be refunded.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission's website [www.keralapsc.org](http://www.keralapsc.org) or photocopied there from. Applications submitted in any other manner will not be considered. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered.
