### NOTIFICATION

The following List contains the names of candidates found suitable on the basis of the result of the Objective Type Test (OMR Valuation) held on 27/09/2008 and verification of original documents of candidates included in the Probability List published on 17/09/2009 for the post of WORK ASSISTANT on Rs.2750– 5530/- (Category No.119/08) in KERALA STATE ROAD TRANSPORT CORPORATION. This Ranked List is brought into force with effect from 31/12/2009.

The List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Script will be rechecked if the candidates apply for it in prescribed application along with a chalan receipt for the prescribed fee of Rs.50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State

under the Head of Account “**0051 PSC-105 State PSC99 Examination fee**” addressed to the Deputy Secretary (Examinations)-II, Kerala Public Service Commission, Pattom PO, Thiruvananthapuram –695 004. Candidates can also apply for a Xerox copy of their answer script. The application should be in the prescribed form (availed in the Commission’s website) along with a chalan receipt for the prescribed fee of Rs.200/- (Rupees Two Hundred only) remitted in any one of the treasuries in the State under the Head of account “0051-PSC-800 other receipts-99-other receipts” addressed to the Deputy Secretary (Exam) II in the above said address. Applications for rechecking and for Xerox copy should reach the office within 30 days from the date of publication of the Ranked List. Applications received after the stipulated time will not be entertained and fee once remitted will not be refunded. Copy of answer sheet will be issued only once to candidate. Copies of OMR answer sheet invalidated by the Commission will not be issued. Candidates are informed that they are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against such persons.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission’s website: [www.keralapsc.org](http://www.keralapsc.org). or photocopied there from. Applications submitted in any other manner will not be considered. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered.

The result of rechecking/copy of script of the candidates who apply as per rules will be intimated/forwarded from this office.
