NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 19.04.2008 and verification of original documents of candidates included in the Probability List published on 31.03.2009 for the post of **Assistant Time Keeper (NCA – Ezhava)** on Rs. 5510 - 8590 in **Printing (Govt. Presses) Department in Kannur District** for which notification for selection was published in the Gazette dated 12-06-2007, arranged in the order of merit. This Ranked List is brought into force w.e.f. 14.05.2009. The Ranked List will be in force until candidates are advised and appointed against the vacancies earmarked for the Ezhava community, but remain unfilled due to paucity of candidates during the currency of the Ranked list for the post published on 26.09.2005.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked if the candidates apply for it along with a chalan receipt for the prescribed fee of Rs. 50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account '0051 PSC 105 State PSC-99 Examination Fee'. The application for rechecking with the original chalan receipt should reach the District Officer, KPSC District Office, Kannur within one month from the date on which this Notification is officially released by the Public Service Commission. Application for re-checking received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission's website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered.
