NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type Test (O.M.R Valuation) held on 19/04/2008 and the verification of original documents of candidates included in the Probability List published on 14/5/2009 for selection to the post of **L.D.Clerk (SR for SC/ST only)** on Rs. 3050-5230(PR) in Various Departments/Kerala Water Authority/Kerala Khadi and Village Industries Board in Malappuram District arranged in the order of merit. The Ranked List is published on the basis of the Gazette Notification for the post dated 13/10/2006 as category No. 108/06. The Ranked List is brought into force with effect from **30/06/2009**. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies, reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. Answer scripts will be rechecked to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers. Re-checking of answer scripts will be done on payment of Rs.50/- (Rupees Fifty only). The fee should be remitted in any of the Treasuries in the State under the Head of Account **"0051 PSC 105 State PSC 99 Examination Fee"**. The original chalan together with the application for re-checking should reach the District Officer, Kerala Public Service Commission, District Office, Malappuram within one month from the day on which this notification is officially released by the Public Service Commission. The fee once remitted will not be refunded on any account. Application for rechecking received after the prescribed time limit will not be entertained.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered. The result of the re-checking will be intimated to the candidate from this office .

Candidates who wish to obtain the Xerox copy of the OMR answer sheet have to remit a prescribed fee of Rs.200/- (Rupees two hundred only) which shall be remitted in any one of the Treasuries in the State which is to be credited to the Head of account "0051-PSC-800 Other receipts-99-other receipts" and the original chalan receipt should be attached with the application. The application form is given with this notification. The copy of the OMR answer script will be given only once and copy of both 'A' part and 'B' part will be given. Copy of invalidated answer scripts will not be given. The Xerox copy will be sent by Registered post to the applicant. Candidate will be given the copy of their own answer script only and if it is proved that application has been given to get the copy of other candidate's answer script legal action will be initiated against the applicant. The application to obtain the Xerox copy of the OMR answer script should reach this office within one month from the date of publication of Ranked List. Xerox copy of answer script will be given for the Ranked Lists published on or after 01/06/2009.

Entries put in column 4 (community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, KPSC District Office, Malappuram within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

The candidates who have secured 53 (fifty three) marks and above in the OMR Test held on 19/4/2008 and who have appeared with necessary documents for the verification of Original Certificates have been included in the Main List of the Ranked List. The cut off marks have been lowered to the extent necessary in respect of candidates included in Supplementary List.
