NOTIFICATION

The following List contains the names of candidates found suitable on the basis of the objective type test (OMR Valuation) held on 9.2.2007 and subsequent verification of original documents held from 23.10.07 to 25.10.2007 and 14.11.07 for the post of Tracer on Rs.3050 – 5230 (PR) in the Town and Country Planning Department (Category No.12/06) arranged in the order of merit. The Ranked List is brought into force with effect from 28.1.2009. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment in accordance with the rules and orders regarding reservation and Rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the prescribed fee of Rs.50/- (Rupees Fifty only) is remitted in any one of the Treasuries in the State by Chalan under the Head of Account "**0051 PSC-105 State PSC99 Examination fee**". Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or down loaded and printed in A4 size paper from the Commission's website: www.keralapsc.org. or photocopied there from. Applications submitted in any other manner will not be considered.

The application for re-checking along with the original chalan receipts should reach the Deputy Secretary (Examinations-I) Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram – 695 004. within 30 days from the date on which this notification is officially released by the Public Service Commission. Application for re-checking received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded. The result of rechecking will be intimated to the candidates from this office.
