NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the OMR Test held on 18/08/2006(For Direct Recruitment), Dictation Test held on 06.10.2007 / 31.03.2009 (for Direct & By Transfer Recruitment), and the verification of original documents of candidates for the post of **Confidential Assistant Grade II** on Rs.3590-5400 (PR) in **Various Departments** in Thrissur District, arranged in the order of merit. The ranked list is published on the basis of the Gazette Notification for the post dated 31/12/2005 as Category No.223/2005 (Direct Recruitment) and 224/2005 (By Transfer Recruitment). The Ranked List is brought into force with effect from 03/08/2009. The Ranked List will be in force till the publication of a new Ranked List for the post after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs. 50/- (Rupees Fifty only) in any one of the treasuries in the state under the Head of Account **"0051 PSC 105 STATE PSC 99 EXAMINATION FEE"**. The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidate from this office. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered. The application for rechecking along with the original chalan receipt for the prescribed fee addressed to the **District Officer, KPSC District Office, Visitors Building, IInd Floor, M.G.Road, Thrissur** should reach this office within 1 month from the date of publication of the Ranked List officially released by the PSC. Application for rechecking received after the prescribed time limit will not be entertained.

Entries put in column (4) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, KPSC District Office, Thrissur within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Candidates who wish to obtain the Xerox copy of the answer sheet have to remit a prescribed fee of Rs. 200/- (Rupees two thousand only) which shall be remitted in any one of the Treasuries in the state which is to be credited to the Head of Account "0051-PSC-800 Other receipts-99-Other receipts" and the original chalan receipt should be attached with the application. The application form is given with this notification. The copy of the OMR sheet will be given only once and copy of both "A" Part and "B" part will be given. Copy of invalidated answerscripts will not be given. The Xerox copy will be sent by Registered post to the applicant. Candidate will be given the copy of their own answer script only and if it is proved that application has been given to get the copy of other candidates answer script legal action will be initiated against the applicant. The application to obtain the Xerox copy of OMR answerscript should reach this office with one month from the date of publication of Ranked list.

The candidates who attended the Dictation test held on 06.10.2007 / 31.03.2009 and who were present with necessary documents of prescribed qualification for the verification of original certificates have been included in the Ranked List.
