Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

**NOTE III:-** Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fees of Rs.200/- in any of the Treasuries in the State (Head of account:0051 PSC- 105 – State PSC - 99 other Receipts). The duly filled in application in the prescribed form (available from the Commission’s website [www.keralapsc.org](http://www.keralapsc.org)) along with the original chalan should be submitted to the **District Officer, Kerala Public Service Commission District Office Pathanamthitta** within one month of the date of publication of this ranked list. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
