NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the objective type test(OMR Valuation) held on 19.04.2008 for the post of **LOWER DIVISION CLERK (SR FOR SC/ST ONLY) ON Rs.3050-5230/- (PR) IN VARIOUS DEPARTMENTS / KWA / KK & VIB (THIS WILL INCLUDE THE INTEGRATED POST OF LD CLERK / VILLAGE ASSISTANT IN THE REVENUE DEPARTMENT.)** in Kollam District arranged in the order of merit. The ranked list is published on the basis of the Gazette Notification for the post dated 13.10.2006 with Category Number 108/06. The ranked list is brought into force with effect from 24.08.2009. The ranked list will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against the vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointments on the basis of the inclusion of their names in the list.

The candidates who have obtained 64 (**Sixty four**) marks and above have been included in the Main List of the Ranked List. The cut off marks have been lowered to the extent necessary in the respect of candidates included in the supplementary list for ST.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, if the candidates apply for rechecking remitting the prescribed fee of Rs.50/- (Rupees fifty only) in any one of the Treasuries in the State under the Head of Account "**0051 PSC 105 State PSC 99 Examination Fee**".

Application for re-checking of answer scripts should be submitted in the prescribed form available free of cost from the

Enquiry Sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered.

Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidate whose Register Number is not included in the ranked list is advised to refer to Notification No. **ER IV(A)3133/08/EW** dated 05.02.2009 for the Register Number of invalidated answer script and the reason there of.

The application for rechecking along with the original chalan receipt should reach the **DISTRICT OFFICER, KERALA PUBLIC SERVICE COMMISSION DISTRICT OFFICE, KOLLAM** within **one** month from the date of publication of the Ranked List. Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. The Fee once remitted will not be refunded on any account. In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this Office.

Entries put in column (7) (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Kollam within 1 (one) month from the date of publication of the ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the list.
