Note 1. Candidates who wish to obtain the Xerox copy of the answer sheet have to remit a prescribed fee of Rs. 200/- (Rupees two thousand only) which shall be remitted in any one of the Treasuries in the state which is to be credited to the Head of Account “0051-PSC-800 Other receipts-99-Other receipts” and the original chalan receipt should be attached with the application. The application form is given with this notification. The copy of the OMR sheet will be given only once and copy of both “A” Part and “B” part will be given. Copy of invalidated answerscripts will not be given. The Xerox copy will be sent by Registered post to the applicant. Candidate will be given the copy of their own answer script only and if it is proved that application has been given to get the copy of other candidates answer script legal action will be initiated against the applicant. The application to obtain the Xerox copy of OMR Answer Script should reach this office with one month from the date of publication of Ranked list.

Note 2 According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs. 50/- (Rupees Fifty only) in any one of the treasuries in the state under the Head of Account “**0051 PSC 105 STATE PSC 99 EXAMINATION FEE**”. The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidate from this office. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered. The application for rechecking along with the original chalan receipt for the prescribed fee addressed to the **District Officer, KPSC District Office, Visitors Building, IInd Floor, M.G.Road, Thrissur** should reach this office within 1 month from the date of publication of the Ranked List officially released by the PSC. Application for rechecking received after the prescribed time limit will not be entertained.
