NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR) Test held on 05.12.2008 for the post of **HOSPITALITY ASSISTANT in TOURISM DEPARTMENT in KASARAGOD DISTRICT on Rs.2650-4150 (Pre-revised)- (Category Number83/07)** arranged in the order of merit. The Ranked List will be in force with effect from **10.11.2009**. The Ranked list will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of answer scripts is not allowed. But rechecking of marks will be done on payment of Rs.50/- (Rupees Fifty only) to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers. The fee should be remitted in any one of the Treasuries in the state under the Head of Account "0051 PSC 105 STATE PSC 99 EXAMINATION FEE". The original Chalan receipt together with the application for re-checking should reach the District Officer, Kerala Public Service Commission, District Office, Kasaragod, within one months from the date of publication of the result. The fee one remitted will not be refunded on any account. Application for rechecking of invalidated script will not be entertained.

Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 Size paper from the Commission's Website : www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered.

The candidates who desires to get the photo copy of their OMR answer scripts should remit the prescribed fee of Rs.200/- in any of the treasuries in the State under the Head of Account “0051-PSC-800 Other receipts 99 Other receipts” and the original chalan receipt should be forwarded along with the application in the prescribed form. Application should be submitted to the District Officer, KPSC District Office, Kasaragod within one month from the date of publication of the Ranked List. The application received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded on any account. Application for issue of copy of invalidated script will not be entertained. Candidates will be given copy of their own answer script only. If application has been given to get copy of the answer script of other candidate, legal action will be initiated against such applicant.

The entries put in Column 4 (community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, KPSC District Office, Kasaragod within one month from the date of publication of the list; to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

All the candidates who were present for verification of Certificates and whose application are provisionally admitted are included in this list.
