NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR valuation) Test held on 18.10.2008 for the post of **LAST GRADE SERVANTS (FULL -TIME WATCHER)** on Rs. 4300-5930 (Category No.449/2007) in **VARIOUS** Departments in Kottayam District arranged in the order of merit. The Ranked List is published on the basis of the Gazette Notification for the post dated 28.11.2007 as Category No. 449/2007 as Re-notification for SIUC Nadar/AI Community. The Ranked List is brought in to force with effect from 19.11.2009. The Ranked List will be in force until candidates are advised and appointed against the vacancies that arise due to the paucity of candidate during the currency of Ranked List published on 23.08.2003.

All the qualified candidates who have appeared for the OMR Test and appeared for the Certificate Verification and proved their qualification as per the Gazette notification have been included in the Ranked List.

According to the existing procedure, revaluation of answer scripts is not allowed. But Answer Scripts will be rechecked, and discrepancies if any will be rectified, if the candidates apply for rechecking remitting the prescribed fee of Rs. 50 /- (Rupees Fifty only) in any one of the Treasuries in the state under the Head of Account "0051-PSC-105-State PSC-99 Examination Fee".

Application for rechecking of Answer Scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its Photocopy or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.org. or photocopied therefrom. Applications submitted in any other manner will not be considered.

Applications for rechecking received from candidates whose Answer Scripts have been invalidated will not be considered. Candidates whose Register Numbers are not included in the Ranked List are advised to refer to notification No.ERII(1)1864/09/EW dated 05.06.2009 for the Register Numbers of invalidated Answer Scripts and the reasons thereof.

The application for rechecking along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office, Muttambalam, Kottayam within one month from the date of publication of the Ranked List. Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. The Fee once remitted will not be refunded on any account. In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Candidates can, if required, obtain the **Xerox Copy of their OMR answer sheets**. The application in the prescribed form should be submitted within one month from the date of publication of Ranked List, alongwith the original chalan receipt for Rs. 200/- remitted in the Head of Account "0051-PSC-800- Other receipts-99-Other receipts". The detailed instructions in this regard and a specimen application form are appended with the Ranked List.
