Applications submitted in any other manner will not be considered.”

The application for rechecking along with the original chalan receipt for the prescribed fee of Rs. 50/- under the head of account “0051 - PSC 105 State PSC 99 – Examination Fee”, addressed to **The District Officer, Kerala Public Service Commission District Office, Wayanad** should reach the office within 30 days from the date of publication of the Ranked List. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

NOTE II:- Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs.200/- in any of the Treasuries in the State (Head of account:0051 PSC- 105 State PSC - 99 other Receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.org) along with the original chalan should be submitted to the **District Officer, Kerala Public Service Commission District Office, Wayanad** within one month from the date of publication of this ranked list. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet

which is not their own, and legal proceedings will be initiated against those who do so.
