NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 18.08.2006 and Dictation Test conducted on 06.10.07 and 31.03.09 and verification of documents that followed for selection to the post of **CONFIDENTIAL ASSISTANT GRADE II** on Rs.3590– 5400/- (PR) in **VARIOUS DEPARTMENTS (Category No.223/2005)** and based on the percentage of marks in SSLC and the Common Dictation Test (Cat. No.224/05) in List II By Transfer category in **KOLLAM DISTRICT** arranged in the order of merit. All the candidates appeared for the dictation tests who were found eligible are included in the list I of the Ranked List.

The ranked list is brought into force with effect from **01.12.2009**. The ranked list will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointments on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, if the candidates apply for rechecking, remitting the prescribed fee of Rs.50/- (Rupees fifty only) in any one of the Treasuries in the State under the Head of Account "**0051 PSC 105 State PSC 99 Examination Fee**". Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission

or its photocopy or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.org or photocopied there from. The original chalan receipt for the prescribed fee should be produced with the application for rechecking.

Valid applications for rechecking addressed to the District Officer, KPSC District Office, Andamukkom, Kollam should reach in this office within one month from the date on which notification of the Ranked List is officially released by the Commission. Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered. The fee once remitted will not be refunded.

In the case of candidates who submit applications for rechecking in the prescribed form within the prescribed time limit enclosing Original Chalan receipt as stated above the marks awarded will be rechecked and the result of the re-checking will be intimated to the candidates from this office.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the treasuries in the State (Head of Account 0051-PSC-800-Other receipts-99-Other receipts). The duly filled up application in the prescribed form available from the Commission Website www.keralapsc.org along with the original chalan should be submitted to the District Offices, KPSC District Office, Kollam within one month from the date of official publication of the Ranked List. A copy of the answer sheet will be issued only once to the candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Entries put on Column 4 are based on the communities specified by the candidates in their application form and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Offices, KPSC District Office, Kollam within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies of any, the candidates will be advised as incorporated in the list.
