Candidates are prohibited from applying for a copy of an answer sheet which is not

their own, and legal proceedings will be initiated against those who do so.

**NOTE II:** A period of one month's time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of publication of the Ranked List. The candidates can avail only one chance after the publication of Ranked List.

Candidates desiring to get rechecked their answer script relating to the written test held for selection to the post may apply for rechecking within 30 days from the date of publication of the Ranked List.

“Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website [www.keralapsc.org](http://www.keralapsc.org) or photocopied there from. Applications submitted in any other manner will not be considered.”
