NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 30/11/2007 for the post of **WORK SUPERINTENDENT** on Rs.3350-5275 (P.R.) in the **AGRICULTURE** Department in Ernakulam District arranged in the order of merit. The Ranked List is published on the basis of the Gazette Notification for the post dated 13/10/2006 with Category Number 95/06 . The Ranked List is brought into force with effect from 03/03/2009. The Ranked List will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointment on the basis of the inclusion of their names in the list.

There are no eligible candidates possessing the prescribed qualification to be included in List I of the Ranked List. The candidates who have obtained 48 (Forty Eight) marks and above have been included in the List II of the Main List. The requisite marks have been lowered to the extent necessary in respect of candidates under the reservation group of communities.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be rechecked, if the candidates apply for rechecking remitting the prescribed fee of Rs.50/- (Rupees fifty only) in any one of the Treasuries in the State under the Head of Account **“0051-PSC-105-State PSC-99-Examination fee”**.

Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered.
