### NOTIFICATION

The following List contains the names of candidates found suitable by the Commission on the basis of the result of the objective type (OMR valuation) test held on 24.5.2008 and verification of original documents of candidates included in the Probability List published on 26.11.2008 for the post of **DRAFTSMAN** Grade II (SR for SC/ST) on Rs.6680 – 10790 (Category No.217/2007) in the Survey and Land Records Department. This Ranked List is brought into force with effect from 4.3.2009.

This List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Script will be rechecked if the candidates apply for it along with a Chalan receipt for the prescribed fee of Rs.50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account "**0051 PSC-105 State PSC99 Examination fee**" addressed to the Deputy Secretary (Examinations)-II, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram – 695 004 should reach the office within 30 days from the date of publication of the Ranked List. Application for rechecking after the stipulated time will not be entertained and fee once remitted will not be refunded.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission's website [www.keralapsc.org](http://www.keralapsc.org) or photocopied there from. Applications submitted in any other manner will not be considered. Applications for

rechecking received from candidates whose answer scripts have been invalidated will not be considered. For Register Numbers of invalidation Please refer Notification number ER II A 2691/08/EW dated 26.11.2008.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.
