ERRATUM NOTIFICATION

It is hereby notified that the following modifications have been made as per G.O. (P)No.24/10/P&ARD dated 02.08.2010 in the ranked list for selection to the post of H.S.A. (English) in Education Department in Malappuram district finalized on 30.11.2010.

The sub heading of Latin Catholic under the Supplementary List is changed as Latin Catholic/Anglo Indian, Separating Anglo Indian from SIUC N/A.I.. Thereby the sub heading SIUC Nadar/Anglo Indian stands changed as SIUC Nadar. The name of the candidate Sri.
