I may inform you as follows.

The name of Sri. Satheesh. K.V. (Reg. No. 200035, Rank No. 55, List - II) provisionally included in the Ranked List for the post of Clerk/Cashier in the District Co-operative Bank in Malappuram District is deleted from the said Ranked List as per directions contained in the letter dated 13.10.2010.

Sri. Hashim Ahamed. L. (Reg. No. 200121 R. No. 18 List-II) was directed to produce unconditional service Certificate as ordered in your letter dated 20.09.2010 and he has produced the same. The provisional inclusion of Sri. Hashim Ahamed. C has been made absolute.

Similarly Smt. Prameela. A (Reg. No. 200031, R. No. 72, List - II) who was directed to produce service certificate attested by the Assistant Registrar (General) has stated that the attesting authority of her service Certificate is the project officer, District khadi and Village industries office, Malappuram since she is working in wandoor tile workers industrial Co-operating society limited which is under khadi board and hence it is not possible to get her service certificate attested by the Taluk Assistant Registrar. (Copy of the petition attached).

Therefore it may be clarified whether the service certificate attested by the project officer Khadi & Village industries office, Malappuram can be accepted in view of the notes in the Gazette Notification. Viz. "the Service Certificate shall be issued by the Assistant Registrar General concerned Co-operative Department or Officer of the same rank in the Government Department in the case of industrial societies".

Yet another candidate Smt. Jayanthi. P.R. (Reg. No. 200085, R. No. 84, List-II) who was directed to produce separate Service Certificates from the two Co-operative Societies mentioning the name of society in which she is working has requested to grant her 15 days more time to produce the same since the concerned Assistant Registrar is on election duty. Showcause memos were issued to two candidates viz. (1) Sri. Rajesh. K.V. (Reg. No. 200111, R. No. 90) and Smt. K.M. Sheejamani (Reg. No. 200040, R. No. 56) as ordered in the letter dated 20.09.2010. But no reply has been record from either of the candidates and hence their names may be deleted from the Ranked List.

Therefore, I may request you to obtain and communicate the orders of the commission on the cases referred above.
