The following list contains the names of candidates found suitable by the commission on the basis of the Endurance test held on 02/03/2010 to 16/03/2010. Those who qualify the Endurance test to conduct a OMR Test held on 05/05/2010 and the Physical Efficiency Test held on 12/05/10 to 25/05/2010 for the Post of **POLICE CONSTABLE IN INDIA RESERVE BETTALION–(COMMANDO WING) IN POLICE DEPARTMENT** on Rs. 6080-9830/-. This Ranked List is brought into force with effect from 22/06/2010. The Ranked list thus published shall ceased to be in force after one year from the date of publication of the Ranked list or after one month from the date of commencement of training in respect of the last batch advised from the Ranked List within a period of one year from the date of finalisation of the Ranked List which ever is later. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the commission during the pendency of the list. As the advise for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Script will be rechecked if the candidates apply for it in the prescribed application along with a chalan receipt for the prescribed fee of Rs. 50/-(Rupees Fifty only) remitted in any one of the Treasuries in the state under the head of account “0051 PSC-105 state PSC 99 Examination fee” addressed to the

Deputy Secretary (Examinations)- II, Kerala Public Service Commission, Pattom P O, Thiruvananthapuram – 695004. Candidates can also apply for a photocopy of their answer script. The application should be in the prescribed form (available in the Commission’s Website) along with a chalan receipt for the prescribed fee of Rs. 200/- (Rupees two hundred only) remitted in any one of the treasuries in the state under the head of account “0051-PSC-800 other receipts – 99 other receipts” addressed to the Deputy Secretary (Examinations) II, in the above said address. Applications for rechecking and for photocopy should reach the office within 30 days from the date of publication of the Ranked List. Applications received after the stipulated time will not be entertained and fee once remitted will not be refunded. Copy of Answer Sheet will be issued only once to candidate. Copies of OMR answer sheets invalidated by the Commission will not be issued. Candidates are informed that they are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against such persons.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s Website www.keralapsc.org. Applications submitted in any other manner will not be considered. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered.

The result of rechecking/ copy of script of the candidates who apply as per rules will be intimated/forwarded from this office.
