NOTIFICATION

The following list contain the names of candidates found suitable and arranged on merit on the basis of marks secured in the OMR Test and Physical Efficiency test for the post of Police Constable in Police Department(India Reserve Batallion-Regular wing) on Rs.6080-9830/- . This Ranked List brought into force with effect from 05/06/2010.

The List will cease to be in force after one year from the date of finalisation of the Ranked List or after one month from the date of commencement of training course in respect of the last batch from the list within a period of one year from the date of finalisation of the Ranked List whichever is later. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Script will be rechecked if the candidates apply for it along with a chalan receipt for the prescribed fee of Rs.50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account "**0051 PSC-105 State PSC99 Examination fee**" addressed to the Deputy Secretary (Examinations)-I, Kerala Public Service Commission, Pattom PO, Thiruvananthapuram –695 004 should reach the office within 30 days from the date of publication of the Ranked List. Application for rechecking after the stipulated time will not be entertained and fee once remitted will not be refunded.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission's website: www.keralapsc.org. or photocopied there from. Applications submitted in any other manner will not be considered. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Entries put in column 9 are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose communities have not been correctly noted in this list as proved by them in their application should intimate the fact to the Deputy Secretary (Examinations) – I Kerala Public Service Commission Thiruvananthapuram – 695 004 within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the list.

Candidates who wish to obtain a photocopy of their answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the Treasuries in the State (head of Account 0051- PSC-800-other receipts-99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the Deputy Secretary (Exam), Kerala Public Service Commission, Pattom, Thiruvananthapuram within one month from the date of publication of the ranked list. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Entries put in column 9 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not being correctly noted in this list as proved by them in their application should intimate the fact to the Deputy Secretary, Examination-I, Kerala Public Service Commission, Thiruvananthapuram-695 004 within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to.
