**NOTIFICATION**

The following list contains the name of candidates found suitable by the Commission on the basis of the results of the Objective Type (OMR) Test held on 15/03/2008 for selection to the post of Lower Division Typist (Ex-servicemen only) on **Rs.4990 – 7990** in the NCC/Sainik Welfare Department in Thiruvananthapuram District arranged in the order of merit. The Ranked List is brought into force with effect from 27.01.2010. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the results and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is not guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of Rs. 50/-. The fee should be remitted in any one of the Treasuries in the State under the Head of Account “**0051 PSC 105 State PSC 99 Examination Fee**”. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or download and printed in A4 size paper from the Commission’s Website/ [www.keralapsc.org](http://www.keralapsc.org) / or photocopies there from. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for re-checking should reach the Deputy Secretary-III, Examinations, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram within one month from the days on which this Ranked List is officially released by the Public Service Commission. The fee once remitted will not be refunded on any account.

The entries put in column 5 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidate whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the Deputy Secretary-III, Examinations, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Candidates who wish to obtain a Photocopy of their Answer Sheet (Part A & Part B) relating to this section shall remit a fee of Rs.200/- by way of chalan in any of the Treasuries in the State (Head of Account 0051-PSC-800-other receipts-99 other receipts). The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the District Officer, Kerala public Service Commission, Thiruvananthauram within one month from the date of publication of the Ranked List. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The Ranked List is provisional subject to the procedure to be followed for implementation of the Supreme Court judgement dated 13.12.1999 on Creamy Layer and alteration of the Supplementary Lists to meet the requirements of reservation as provided in Rules 14 to 17 of KS&SS Rules.
