NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on **03.04.2009** and Physical measurement of the candidates included in the Probability List published on 23.11.2009 for the post of **DEPOT WATCHER/ RESERVE FOREST WATCHER (NCA Recruitment for EZHAVA)** on Rs.4300-5930 in **FOREST DEPARTMENT** in **KASARAGOD DISTRICT** for which notification for selection was published in the Gazette dated 31.01.2008, arranged in the order of merit. This Ranked List is brought into force with effect from **06.05.2010**.

The Ranked List will remain in force until candidates are advised and appointed against the vacancies earmarked for Ezhava community, but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post on 18.11.2004 in Kasaragod district.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done if the candidates apply for it along with a chalan receipt for the prescribed fee of Rs. 50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account '0051 PSC 105 State PSC-99 Examination Fee'.

The application for rechecking with the original chalan receipt should reach the **District Officer, KPSC District Office, Kasaragod** within one month from the date on which this notification is officially released by the Public Service Commission. Application for re-checking received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded.

Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission's website www.keralapsc.org or photocopied therefrom. Applications submitted in any other manner will not be considered. Applications for re-checking of invalidated script, will not be entertained.

The candidates, who are willing to obtain the photo copies of their OMR Answer Scripts should remit prescribed fee of Rs.200/- in any one of the Treasuries in the State under the Head of Account "0051-PSC-800 Other Receipts -99 - Other Receipts". The application for obtaining photo copy of OMR Answer Scripts should be in the prescribed form as published along with this notification and should reach the District Officer, KPSC District Office, Kasaragod within one month from the date of publication of the Ranked List.

The application received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded.

Entries put in Column 4 (community) are based on the communities specified by the candidates in their applications and proved with the necessary documents.
