NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR) Test held on 17.10.2008 and the verification of original documents of candidates included in the Probability List published on 12.03.2010 for selection to the post of **PHARMACIST GRADE II** on **Rs. 4000 - 6090/-** in **Health Services Department in Palakkad District (Cat. No. 78/2007)** arranged in the order of merit. The Ranked List is brought in to force with effect from **08.07.2010**. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer scripts is not allowed. But rechecking of marks will be done on payment of Rs.50/- (Rupees fifty only). The fees should be remitted in any one of the Treasuries in the state by chalan under the Head of Account **“0051-PSC- 105- State PSC -99 Examination Fee”**. The fee once remitted will not be refunded on any account. The result of the re-checking will be intimated to the candidates from this office. Application for re-checking of answer script should be submitted in the prescribed format available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website : www.keralapsc.org or photocopies there from . Applications submitted in any other manner will not be considered. The application for re-checking along with the original chalan receipt for the prescribed fee addressed to the **District Officer, KPSC District Office, Palakkad** should reach this office **within one month** from the date of publication of the Ranked List officially released by the Public Service Commission. The application for rechecking received after the prescribed time limit will not be entertained.

Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit the fees of Rs.200/- (Rupees Two hundred only) in any one of the Treasuries in the State by chalan under the Head of Account **“0051-PSC-800- other receipts 99 – other receipts”**. The duly filled in application in the prescribed form (available from the Commission's website.) along with the original chalan should be submitted to the District officer , KPSC, District Office, Palakkad within one month from the date of publication of the Ranked List officially released by the KPSC. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Entries put in column 4 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission, District Office Palakkad within one month from the date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

The candidates who have secured **34 (Thirty four)** marks and above in the Objective Type (OMR) Test have been included in the Main List of the Ranked List. The marks have been lowered to the extent necessary in respect of candidates included in the Supplementary List.
