NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type Test (OMR valuation) held on 30.09.2009 and the verification of original documents of candidates included in the probability list published on 04.06.2010 for the post of **Mechanical Operator on Rs. 2750 - 4625/- in Pharmaceutical Corporation (IM) Kerala Limited** arranged in the order of merit. The Ranked List for the post is published on the basis of the Gazette Notification dated 28.09.2007 as **Category No. 330/2007** for recruitment. The Ranked List is brought into force with effect from 13.07.2010. The Ranked List will be in force till the publication of a new Ranked List for the post after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs. 50/- (Rupees Fifty Only) in any one of the Treasuries in the state under the Head of Account “**0051 PSC 105 STATE PSC 99 EXAMINATION FEE**”. The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidate from this office. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website www.keralapsc.org or photocopied there from. Applications submitted in any other manner will not be considered.

The application for rechecking along with the original chalan receipt for the prescribed fee addressed to the **Regional Officer, KPSC Regional Office, Kozhikode** should reach this office within one month from the date of publication of the Ranked List officially released by the K.P.S.C. Application for rechecking received after the prescribed time limit will not be entertained.

Entries put in column (4) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the Regional Officer, KPSC Regional Office, Kozhikode within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

The candidates who have obtained **56 (Fifty Six)** marks and above have been included in the Main List of the Ranked List. The cut off marks have been lowered to the extent necessary in respect of candidates included in Supplementary Lists.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fees of **Rs. 200/-** in any of the Treasuries in the State (**Head of Account: “0051-PSC-800 Other Receipts-99-other receipts”**). The duly filled in application in the prescribed form (available from the Commission’s website www.keralapsc.org) along with the original chalan should be submitted to the **Regional Officer, Kerala Public Service Commission, Regional Office, Kozhikode** within one month of the date of publication of this Ranked List. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
