NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on **23.05.2009** and verification of original documents of candidates included in the probability list published on **28.09.2010** for the post of **FIELD WORKER (Special Recruitment for SC/ST)** on Rs.4400-6680 in the **HEALTH SERVICES** Department in Kasaragod District for which notification for selection was published in the Gazette dated **31.10.2007**, arranged in the order of merit. This Ranked List is brought into force with effect from **30.11.2010**.

The list will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. ***Candidates against vacancies reported exclusively for scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in the list that fresh notification for vacancies reserved exclusively for scheduled Tribes will be issued.*** As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all, for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked, if the candidates apply for rechecking along with a chalan receipt for the prescribed fee of Rs.50/- (Rupees fifty only)remitted in any one of the Treasuries in the State under the Head of Account "**0051 PSC 105 State PSC 99 Examination Fee**".

The application for rechecking along with the original chalan receipt should reach the District Officer, Kerala Public Service Commission District Office, Tiger Hills, Pulikkunnu, Muncipal Office Road, Kasaragod within **45 days** from the date of publication of the ranked list. Application for rechecking received after the prescribed time limit will not be entertained. The Fee once remitted will not be refunded. In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

The application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photo copy or downloaded and printed in A4 size paper from the Commissions Website www.keralapsc.org or photocopied therefrom. Applications submitted in any other manner will not be considered. Applications for rechecking of invalidated script will not be entertained.

The candidates, who are willing to obtain the photo copies of their OMR Answer Scripts should remit prescribed fee of **Rs.200/-** in any one of the Treasuries in the State under the Head of Accounts “0051-PSC-800 Other Receipts-99-Other Receipts”. The application for obtaining photocopy of OMR answer scripts should be in the prescribed form as published along with this notification and should reach the District Officer, KPSC District Office, Kasaragod within 45 days from the date of publication of the Ranked List. Request for issue of photocopy of invalidated script will not be considered.

Valid application for **Re-checking/obtaining the photo copy of answer script** addressed to The District Officer, KPSC District Office, Tiger Hills, Pulikkunnu, Municipal Office Road, Kasaragod shall reach this office within **45 days** from the date on which the Ranked List has come in to force. The last date fixed for receipt of application for rechecking/obtaining photo copy of the answer script is **13.01.2011**. Applications for rechecking/obtaining photo copy, received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded.

Entries put in Column 4 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, KPSC District Office, Kasaragod within **1(one) month** from the date of publication of the ranked list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.
