NOTIFICATION

The following is the Probability List containing the Register Numbers of candidates who are found provisionally eligible to be included in the Ranked List, subject to the verification of the original documents, for selection to the post of SUPERVISOR (ICDS) on Rs. 7990-12930 (Category No. 70/2008) in the SOCIAL WELFARE DEPARTMENT on the basis of the Objective Type Test (OMR valuation) held on 20.11.2008.

The Register Numbers are arranged in their numerical sequence and the arrangement does not in any way indicate their respective rank on the basis of the said test. The Original Certificates to prove Date of Birth, Community, Period of Service, Qualifications etc in respect of the candidates will be verified before the Ranked List is finalised and published. The date, time and venue for verification of original documents will be intimated later through print media and website of Kerala Public Service Commission.

Note 1: Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of applications on absolute basis. Inclusion of Register Numbers in the Probability List does not confer any right on the candidate to be called for Certificate verification or for subsequent inclusion in the Ranked List.

Note 2: The Probability List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

The candidates who have secured 35 (Thirty five) marks and above are included in the Main List of Probability List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to Other Backward Classes included in this List who are required to produce Non Creamy Layer Certificate as per GO (P) No. 117/2008/SC/ST/DD dated 19.12.2008 shall produce the same along with other documents mentioned above at the time of verification of original documents. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to get the benefit of community reservation and will be considered as open competition candidates. As regards such candidates in the Supplementary Lists of other Backward classes, their register numbers will be deleted from the Probability List without further notice, if they fail to produce the Non Creamy Layer Certificate.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts after publication of the Ranked List for the post. Detailed instructions will be found in the Ranked List Notification for this post.

Candidates who wish to obtain a photocopy of their answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the Treasuries in the State (head of Account 0051-PSC-800-other receipts-99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the ***Deputy Secretary(Exam), Kerala Public Service Commission, Pattom, Thiruvananthapuram*** within one month from the date of publication of the ranked list. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
