The requisite marks have been lowered to the extent necessary in respect of the candidates included in the Supplementary List. All the candidates who have appeared for the OMR test as per category No.21/2006 are included in the **LIST-II**.

Note: 5.(i) The candidates belonging to Other Backward Classes included in the Probability List, who are required to produce Non Creamy Layer Certificate as per G. O (P) No. 117/08/SCSTDD dated

19.12.2008 shall produce the same along with the other documents at the time of certificate verification.

- (ii) The candidates belonging to Scheduled Castes and Scheduled Tribes included in the Probability List shall produce Community Certificate vide G.O (MS) No. 318/08/Revenue dated 25.08.2007 obtained from Tahsildar along with other documents at the time of certificate verification.

Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate or Community Certificates will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary List, their register numbers will be deleted from the Probability List without further notice, if they fail to produce the Non Creamy Layer Certificate/ Community Certificate.
