Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate or Caste Certificate will not be entitled to the benefits of community reservation and will be treated as Open Candidates.

Those who fail to produce their Certificates on the day fixed for Certificate Verification in person will be deleted from the List without further notice. Since the process of finalization of the Ranked List is time bound, no time will be granted to any candidate in any circumstances to produce any documents in Original or copies. Hence the candidates should give special attention to see that their chances are not lost by their absence for the Verification.
