Those candidates who are excluded from producing Non-Creamy Layer Certificate have to produce Community Certificates from the authority, concerned at the time of verification.

Candidates belonging to SC and ST have to produce original and two attested copies of Caste Certificate at the time of verification.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked **only after the publication of Ranked list.**

5. *Sportsmen* : Certificate attested by the Sports Council.
6. *Service Candidates* : No Objection Certificate obtained from Head of Office or Head of Department.
