Candidates included in the list will have to produce in person at their own expense, the original certificates and self attested copies, to prove their Date of Birth, Community, Qualifications, Discharge Certificate, Pension Payment Order etc. as claimed in their application. The candidates belonging to SC/ST communities shall produce caste certificate and two self attested copies of the same.

The candidates belonging to Other Backward Communities, shall produce Non-creamy Layer Certificate as per G.O.(P) No:117/2008/SC/ST/DD, dated, 19.12.2008 to claim their benefits. Such candidates in the Main List who fail to produce the required Non-creamy Layer Certificate or Caste Certificate will not be entitled to the benefits of community reservation and will be treated as open candidates.

Those who fail to produce their certificates on the day fixed for certificate verification, in person will be deleted from the list without further notice.

Since the process of finalisation of the Ranked List is time bound, no time will be granted to any candidate in any circumstances to produce any documents in original or copies. Hence the candidate should give special attention to see that their chances are not lost by their absence for the verification.

The verification of documents of candidates included in the probability list will be conducted on **04.03.2009 at 08.00 a.m.** at **Kerala Public Service Commission District Office, Alappuzha.**
