1. Age and Date of Birth: SSLC or equivalent Certificate (Copy and Original).

2. Educational Qualification:
 - i. Minimum General Educational Qualification of SSLC Standard
 - ii. Should possess any of the qualification mentioned below.
 - a. Lower Grade Drawing Group Certificate MGTE/KGTE
 - b. Second Grade Certificate secured by Draftsman Civil Trainees under the TT Scheme, College of Engineering Thiruvananthapuram or under Industrial Training Centre conducted by the Government of India (Ministry of Labour) after a course of 18 months.
 - c. Diploma in Craftsmanship (Civil) obtained after a course of 18 months at the Industrial Training Institute of the Kerala State or any course recognized as equivalent thereto by the Government of Kerala.
 - d. Building, Drawing and estimating (Higher or Lower) and any two of the other civil engineering subjects (Higher or Lower) under MGTE/KGTE.

If possessed higher qualification should produce copy of original of the certificates.

3. Community and Caste

SC/ST candidates should produce community certificates (Two Self attested Copies and original) obtained from the Tahsildar. Candidates belonging to other backward communities shall produce Non Creamy Layer Certificate as per G O (P) No.46/2007 SC/ST DD Dated 25.8.07, or G O (P) No.4/2008 SC/ST DD Dated 3.1.2008 (Self attested copy and Original)
