- 2) The Probability List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.
- 3) Serial numbers of 3% reservation i.e. 33, 66 and 99 shall be filled up in vacancies of Draftsman (Electrical) in PWD/Irrigation Department, since Overseer Grade II (Electrical) in PWD/Irrigation Department is not seen included in the list of posts eligible for 3% reservation, of P.H candidates.
- 4) The candidates who have secured **96 (Ninety Six)** marks and above are included in the Main list of Probability List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists . A separate list for eligible physically handicapped candidates in the order of register numbers is published as List II.

The candidates belonging to other backward classes included in this list who are required to produce Non Creamy Layer Certificates as per G O (P) No.117/2008/SC/ST/DD Dated 19/12/2008 shall produce the same along with the other documents mentioned above at the time of verification of original documents. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to get the benefit of community reservation and will be considered as open competition candidates. As regards such candidates in the Supplementary Lists of other Backward classes, their register numbers will be deleted from the Probability List without further notice, if they fail to produce the Non Creamy Layer Certificate.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts after publication of the Ranked list for the post. Detailed instruction will be found in the Ranked List notification for this post

Candidates who wish to obtain a photocopy of their answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the Treasuries in the State (head of Account 0051-PSC-800-other receipts-99 other receipts). The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the Deputy Secretary (Exam), Kerala Public Service Commission, Pattom, Thiruvananthapuram within one month from the date of publication of the ranked list. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
