Note 4:- Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fees of Rs.200/- in any of the Treasuries in the State (head of account 0051 PSC – 800 Other Receipts – 99 - Other receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.org) along with the original chalan should be submitted to the Regional Office, Ernakulam within one month of the date of publication of this Ranked List. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own and legal proceedings will be initiated against those who do so.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of Ranked List.

Candidates whose register numbers are not included in the Short List are advised to refer to the Notification No.ER V/2529/2009/EW dated 06.07.2009 for the register numbers of invalidated answer scripts and the reasons thereof.
