Candidates whose register numbers are included in the Short List are directed to send self attested copies of documents to prove their claims made in the application, ie, qualification, date of birth, community and other benefits, if any to which they are entitled to the District Officer, Kerala Public Service Commission, District Office, Thrissur, within 15 days from the date of publication of this Notification. The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.

The Candidates who have secured 49 marks and above for the OMR Test held on 07-02-2009 are included in the Main List of List I. Marks have been lowered to the extent necessary in respect of Supplementary Lists. All the candidates who have appeared for the OMR Test under By Transfer Category are included in List II

The candidates belonging to the Other Backward Classes, included in List I who are required to produce Non-Creamy Layer Certificate as per GO(P) No.117/2008/SCSTDD dated 19/12/2008 shall produce the same at the time of interview. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of Community and will be considered as open competition candidates.

The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked after the publication of the Ranked List, if the prescribed fee of **Rs. 50/- (Rupees fifty only)** is remitted in any one of the treasuries in the state by chalan under the head of account “**0051 PSC – 105 State PSC – 99 Examination Fee**”. Applications for rechecking should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or downloaded and printed in A4 size paper from the Commission’s web site [www.keralapsc.org](http://www.keralapsc.org) or photocopied there from. The original chalan receipt for the prescribed fee should be produced with the application for rechecking. Applications of rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose register numbers are not included in the short list are advised to refer to Notification (copy enclosed) No. ER VII(1)3785/09/EW dated 29.10.09 of Secretary, KPSC, TVPM for the register numbers of invalidated answer scripts and the reasons thereof. Candidates whose register numbers are not included in the Short List should submit the application for rechecking within one month from the date of publication of the Ranked list. Candidates whose register numbers are included in the Short List may also apply for rechecking within one month from the date of publication of the Ranked List.

Valid applications for rechecking, addressed to the District Officer, Kerala Public Service Commission, District Office, M.G. Road, Thrissur - 4 should reach this office within 30 days from the date on which Ranked list is officially released by the Kerala public Service Commission. Applications for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send applications for re-checking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Candidates who wish to obtain the Xerox copy of the OMR answer sheet have to remit a prescribed fee of Rs.200/- (Rupees two hundred only) which shall be remitted in any one of the Treasuries in the State which is to be credited to the Head of Account ‘‘0051 – PSC-800 other receipts –99 – Other receipts and the original chalan receipt should be attached with the, application. The application form is given with this notification. The copy of the OMR Sheet will be given only once and copy of both ‘A’ part and ‘B’ part will be given. Copy of invalidated answerscript will not be given. The Xerox copy will be sent by Registered post to the applicant. Candidate will be given the copy of their own answerscript only and if it is proved that application has been given to get the copy of other candidate’s answerscript, legal action will be initiated against the applicant. The application to obtain the Xerox copy of the OMR answer script should reach this Office within one month from the date of publication of Ranked List.
