The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.

The candidate who have secured 43 (Forty three) marks and above are included in the Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non-Creamy Layer Certificate as per G.O (P) No. 46/07/SC STDD dated 25.8.2007 or GO (P) No. 117/08 SC STDD dated 19/12/2008 shall produce the same along with the other documents as and when called for. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition Candidates. As regards such candidates in the Supplementary Lists of other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate.

The date, time and place of interview will be intimated in due course.

Rechecking of answer scripts will be allowed only after the publication of the Ranked List.
