4. Candidates whose register numbers are included in the Short List are directed to send self attested copies of documents to prove their claims made in the application, ie, qualification, date of birth, community and other benefits, if any to which they are entitled to the District Officer, Kerala Public Service Commission, District Office, Thrissur, within 15 days from the date of publication of this Notification. The register

numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.

5. (1) The candidates belonging to the Other Backward Classes, included in the Short List, who are required to produce Non-Creamy Layer Certificate as per GO(P)117/2008/SC/STDD dated 19/12/2008 shall produce the same along with other documents mentioned above as and when called for.
- (2) The Candidates belonging to Scheduled Castes and Scheduled Tribes included in the Short List shall produce Community Certificate vide G.O(M.S) NO.318/08/Revenue dated 25.08.2007 obtained from Tahsildar along with other documents mentioned above as and when called for.

Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate or Community Certificate will not be entitled to the benefit of Community reservation and will be considered as open competition candidates. As regards such candidates in the Supplementary Lists, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate/Community Certificate.

6. **The place, date and time of interview will be intimated in due course.**
7. (1) Rechecking of Answer Scripts will be allowed only after the publication of the Ranked List
- (2) Copy of the OMR Answer Scripts will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List. Detailed instruction in this regard will be issued in the Ranked List Notification.
8. Candidates whose register numbers are not included in the Short List are advised to refer to notification No. ER VII(2)2530/09/E.W dated 23.10.2009 for the register numbers of invalidated Answer Scripts and the reason there of.
