Note: 2 The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note : 3 Candidates whose Register Numbers are included in the Short List are directed to send self attested copies of documents to prove their claims made in the application in respect of qualification, Date of birth, Community and other benefits, if any to which they are entitled, to the **District Officer, Kerala Public Service Commission District Office Malappuram-676 505** within 15 days from the date of publication of this Notification. The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.

The candidates who have secured **53 (Fifty Three)** marks and above are included in the Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to Other Backward Classes included in the Short List, are required to produce Non-Creamy Layer Certificate as per G.O (P) No. 117/2008/SCSTDD dated 19/12/2008 and SC/ST candidates shall produce Community Certificate issued by the Tahsildar for the specific purpose along with the other documents mentioned above. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate/Community Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition Candidates if otherwise eligible. As regards such candidates in the Supplementary Lists of SC/ST and other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Community Certificate / Non-Creamy Layer Certificate. Candidates whose Register Numbers are not included in the Short List are advised to refer to Notification No. ERVII(1)3785/09/EW dated 29/10/2009 for the Register Number of invalidated answer scripts and the reasons thereof.

The date, time and place of interview will be intimated in due course.

According to the existing procedure revaluation of answer scripts is not allowed. The answer scripts will be rechecked only after the publication of the Ranked List if the prescribed fee of **Rs. 50/- (Rupees Fifty only)** is remitted in any one of the Treasuries in the state by chalan under the head of account "**0051 PSC -105 State PSC – 99 Examination Fee**". Application for rechecking of answer scripts should be submitted within one month from the date of publication of the Ranked List in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or downloaded and printed in A4 size paper from the Commissions website www.keralapsc.org or photocopied therefrom. The original Chalan receipt for the prescribed fee should be produced with the application for rechecking. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered.

Candidates whose register numbers are included or not included in the Short List and Ranked List can apply for rechecking of their answer scripts within one month from the date of publication of Ranked List. Candidates who require the Xerox copy of their OMR answer sheet (both A part and B part) may remit a fee of Rs.200/- on the head of account "0051-PSC-800 other receipts-99-other receipts" with original chalan receipt should apply to the office of the Commission within one month after the publication of the Ranked List in the prescribed form.

Valid applications for rechecking addressed to the District Officer, Kerala Public Service Commission District Office, Civil Station, Malappuram should reach this office within 30 days from the date on which the notification of Ranked List is officially released by the Kerala Public Service Commission. Applications for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.
