Note – 2 :- The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

The candidates who have secured 65 (sixty five) marks and above in the written test are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The date, time and place of interview will be intimated in due course.

Re-checking of answer scripts will not be allowed before publishing the Ranked List.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of Ranked List if the prescribed fee of Rs. 50/- (Rupees Fifty only) is remitted in any one of the Treasuries in the state by Challan under the Head of Account “0051 PSC – 105 State PSC – 99 Examination Fee”. Applications for re-checking of answer script should be submitted within one month from the date of publication of the Ranked List in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or down load and printed in A4 size paper from the Commission’s Web site/www.keralapsc.org or photocopied there from. The original Challan receipt for the prescribed fee should be produced with the application for re-checking. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose register numbers are included or not included in the Short List and Ranked List can apply for re-checking of their answer scripts, with in one month from the date of publication of the Ranked List. Valid applications for re-checking addressed to the District Officer, Kerala Public Service Commission District Office, Kakkanad, Ernakulam should reach this office within 30 days from the date on which the Ranked List is officially released by the Kerala Public Service Commission. Applications for re-checking received after the prescribed time limit or not in the prescribed form will not be entertained. The Fee once remitted will not be refunded. In the case of candidates who send applications for re-checking in the prescribed form within the prescribed time limit enclosing original Challan receipt as stated above, the marks awarded will be re-checked and the result of the re-checking will be intimated to the candidates from this office.
