Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.

The date, time and place of interview will be intimated in due course.

According to the existing procedure revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of Ranked List.
