5.(i) The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per G. O (P) No. 117/08/SC/STDD dated 19.12.2008 shall produce the same along with the other documents mentioned above or as and when called for.

(ii) The candidates belonging to Scheduled Castes and Scheduled Tribes included in the Short List shall produce Community Certificate vide G.O (MS) No. 318/08/Revenue dated 25.08.2007 obtained from Tahsildar along with other documents mentioned above or as and when called for.

Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate or Community Certificates will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary List, their register numbers will be deleted from the Short List without further notice., if they fail to produce the Non Creamy Layer Certificate/ Community Certificate .
