(3) Candidates whose register numbers are included in the short list are directed to send self attested copies of documents to prove their claims made in the application, i.e qualification, date of birth, Community and

other benefits including nativity if any, to which they are entitled, to the District Officer, KPSC District Office, Ernakulam, Kakkanad P.O., within 15 days from the date of publication of this notification. The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

All the candidates who have appeared for the OMR Test held on 09.05.2008 are included in the Short List.

The candidates belonging to Other Backward Classes included in the Short List who are required to produce Non Creamy Layer Certificate as per G O (P) No. 117/2008/SC/STDD dated 19.12.08 shall produce the same along with other documents mentioned above or as and when called for. Those who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefits of the Community reservation and their Register Numbers will be deleted from the Short List without further notice.

The venue, date and time of Practical Test will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of Ranked List for the post. Detailed instruction in this regard will be found in the Ranked List notification for this post.
