Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of applications on absolute basis. Inclusion of Register Numbers in the Short List does not confer any right on the candidate to be called for practical Test or for subsequent inclusion in the Ranked List.

- (2) The Short List is prepared based on the details furnished by the candidates in the applications and subsequent claims made will not be entertained at any stage
- (3) Candidates whose register numbers are included in the short list are directed to send self attested copies of documents to prove their claims made in the application, i.e qualification, date of birth, Community and other benefits including nativity if any, to which they are entitled to the District Officer, KPSC District Office, Ernakulam, Kakkanad P.O., within 15 days from the date of publication of this notification. The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The candidates belonging to Non-reservation group of communities, who have secured 34 (Thirty four) marks and above are included in the Short List. The requisite marks have been lowered to the extent necessary in respect of candidates belonging to the reservation group of communities.

The candidates belonging to Other Backward Classes included in the Short List who are required to produce Non Creamy Layer Certificate as per G O (P) No. 117/2008/SC/STDD dated 19.12.08 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to benefits of community reservation and will be considered as open competition candidates. As regards such candidates in the Supplementary List of Other Backward Classes, their Register Numbers will be deleted from the Short List without further notice if they fail to produce the Non-Creamy Layer Certificate.

The Place, date and time of Practical Test will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of Ranked List for the post. Detailed instructions in this regard will be found in the Ranked List Notification for this post.
