According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of Ranked List if the prescribed fee of Rs. 50/-(Rupees Fifty only) is remitted in any one of the Treasuries in the state by Chelan under the Head of Account '0051-PSC-105 State PSC-99 Examination Fee'. Applications for rechecking of answer script should be submitted within one month from the date of publication of the Ranked List in the prescribed form available free of cost from the enquiry section of the various offices of the Commission or down load and printed in A4 size paper from the Commissions website/www.keralapsc.org or photocopied there from. The original Chelan receipt for the prescribed fee should be produced with its application for rechecking. Candidates whose register numbers are not included in the Ranked List can also apply for rechecking within one month from the date of publication of the Ranked List.

Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered.

Application for re-checking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chelan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates.
