The duly filled in application in the prescribed form (available from the official website of the Commission) along with the original chalan should be submitted to the Deputy Secretary (Examinations-1) Kerala Public Service Commission, Pattom, Thiruvananthapuram within one month of the publication of the Ranked List for this post. The copy of the answer scripts will be issued only once. Copies of OMR answer scripts invalidated due to any defect will not be issued. Candidates are prohibited from applying for the copy of answer script which is not their own, and legal proceedings will be initiated against them who violate this instruction.
