 3. All the candidates who have appeared for the Examination are included in the above List.
 4. The place, date and time of Physical Efficiency Test will be intimated in due course.
 5. According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of Ranked List if the prescribed fee of Rs. 50/- (Rupees Fifty only) is remitted in any one of the

Treasuries in the state by Challan under the Head of Account “0051 PSC – 105 State PSC – 99 Examination Fee”. Applications for re-checking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or download and printed in A4 size paper from the Commission’s Web site/www.keralapsc.org or photocopied there from. The original Challan receipt for the prescribed fee should be produced with the application for re-checking.

6. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose register numbers are included or not included in the Short List and Ranked List can apply for re-checking of their answer scripts, with in one month from the date of publication of the Ranked List.
7. Valid applications for re-checking addressed to the Deputy Secretary- III, Examinations Kerala Public Service Commission, Pattom.PO,Thiruvananthapuram should reach this office within 30 days from the date on which this Notification or Ranked List is officially released by the Kerala Public Service Commission. Applications for re-checking received after the prescribed time limit or not in the prescribed form will not be entertained.
8. The Fee once remitted will not be refunded.
9. In the case of candidates who send applications for re-checking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be re-checked and the result of the re-checking will be intimated to the candidates from this office
10. Candidates who wish to obtain a Photocopy of their OMR Answer Sheet (Part A & B) relating to this selection shall remit the fees of Rs.200/- in any one of the Treasuries in State (Head of Account : 0051 PSC 800 other receipts – 99 other receipts). The duly filled application in the prescribed form (available from the commission website) along with the original chalan should be submitted to the Deputy Secretary-III (Examination), Kerala Public Service Commission, Pattom, Thiruvananthapuram within one month of the date of publication of Ranked List. A copy of an Answer Sheet will be issued only once to the candidate. Copies of OMR Answer Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not in their own, and legal proceedings will be initiated against those who do so.
